Take a closer look at what CARFAX provides

Eligibility

To be eligible for CARFAX benefits, you must be a regular full-time (FT) employee. Benefits begin on date of hire. *Benefits are subject to annual review and changes.* * *Permanent part-time (PT) and fixed-term employees who work 20+ hours a week may be benefits eligible.*

Medical/Dental/Vision Insurance

CARFAX offers a flex benefits plan to all regular employees and their dependents. Employees receive annual "flex credit dollars" to make decisions about the benefits that are best for them. All premiums are employer-paid.

Short-Term Disability and Long-Term Disability

The **STD plan** includes benefits for salary continuation that will pay 100% of base salary when away from work due to a covered disability for up to 26 weeks.

The **LTD** plan pays up to a maximum monthly non-taxable benefit of \$15,000 at the following rates: 60% of annual earning to a maximum of \$3,000 and 50% of the remainder. **This coverage is mandatory, and employee paid through payroll deductions.*

Life and Accidental Death and Dismemberment

We provide **basic life insurance** and **accidental death and dismemberment (AD&D) insurance** coverage, each equal to 2x your annual base salary. We also offer **dependent life insurance** of \$10,000 for spouse and \$5,000 for child. *This coverage is provided at no cost to you!*

Employees can also purchase supplemental life and AD&D. The cost of additional coverage is based on age and the amount of coverage elected.

Defined Contribution Pension Plan (DCPP)

Planning for retirement is important, and at CARFAX, we understand the value of investing in your future! Our DCPP plan matches contributions up to 6% of your base salary each pay period to maximize your retirement savings. **There is a mandatory 2% contribution for all employees.*

Calm Premium

Employees and up to five of their dependents have access to a fully paid Calm Premium membership.

Wellness Reimbursement

We know how important it is to take care of yourself. That's why CARFAX will reimburse you 100% for eligible expenses, up to \$750 CAD* annually. **This is a taxable benefit*.

Employee Assistance Program (TELUS Health One)

TELUS Health is a total wellbeing solution committed to connecting mental, physical, and financial wellbeing services, so you can easily access a broad range of support from a single point of entry at any point in your wellbeing journey. Through our EAP, employees can also access free virtual fitness and mindful moments.

Employees at all levels have access to confidential career coaching to provide customized support to see the possibilities.

Consult + Virtual Health Services

With **Consult+**, eligible employees can have 24/7 access to qualified doctors, nurses, and other healthcare professional.

When a critical illness or condition is diagnosed **Teladoc Medical Experts** provides all regular employees with access to the right information, diagnosis, and treatment with work-renowned specialist and several resources.

This coverage is provided at no cost to you!

Critical Illness

Critical Illness insurance provides financial protection by paying a lump sum benefit if you are diagnosed with a covered critical illness. Costs are based on age, gender, smoking status, and the amount of coverage elected. *Coverage is optional and there is a cost to you.

Volunteer Time Off

CARFAX encourages employees to give back to their local community! We offer 3 paid days off to contribute your time and talents.

Parental Leave

CARFAX is proud of offer up to 26 weeks of paid leave to any parent to care for and bond with a child after birth, adoption, or foster-care placement.

Jury Duty

CARFAX supports civic responsibility. While on jury duty or subpoenaed court appearances, employees are paid for normal hours missed at base pay.

Vacation

Time off work is important! Both FT and PT employees receive paid vacation tied to length of service:

Tenure	СТО
Less than 2 years	15 days
2 years but less than 5	17 days
5 years but less than 10	20 days
10 years but less than 15	25 days
15 years or more	30 days

Vacation is pro-rated based on start date for first your first year. Accruals for PT employees are pro-rated based on work hours.

Flexible Time Off (FTO)

Employees are provided with four (4) days of Flexible Time-Off (FTO) per fiscal year for illnesses, appointments, and other reasonable absences each fiscal year. *FTO is prorated your first year of employment.*

Bereavement Leave

Employees may take up to five (5) days of paid leave per year for the loss of a loved one, including pets.

Four Day Summer Work Week (2024)

This year CARFAX will enjoy a "Four Day Summer Work Week." From Victoria Day through Labour Day, there will be an additional 12 Fridays off in 2024.
