



Pioneer Human Services (Pioneer) has recognized the valuable and wide set of skills an EMT can provide to a challenging population. We have discovered that by implementing EMS into a role that works with case managers, social workers, chemical and mental health therapists, we are able to not only help people in their moment of need, but provide lasting changes in the lives of those we serve. Our programs also provide a desperately needed resource for our infield first responders and local emergency departments.

Pioneer is a licensed EMS agency offering full license affiliation. We provide quarterly training that meets the requirements for Washington State DOH certification renewal through OTEP (on-going training and evaluation program).

We utilize EMTs to divert patients in our communities away from costlier services such as emergency rooms, clinics, jails, fire/EMS and law enforcement response.

Currently, we employ EMTs in both King and Snohomish county in fixed site programs. These programs utilize an EMT's ability to make accurate clinical and medical impressions to determine program suitability or refer to other resources within the emergency management system. In both programs, EMTs work closely with local hospitals, clinics, fire departments and law enforcement.

What makes our use of EMS different

Our Snohomish County Diversion Center is a 44-bed facility that provides short-term placement and shelter to homeless adults with a substance use disorder and other behavioral health issues. Clients are brought to the facility through law enforcement and an embedded social worker. A client's typical stay at this program is up to two weeks.

Our King County Diversion Center is a 55-bed facility that provides a safe place for the chronically unhoused to be medically monitored and sleep off the effects of drugs and alcohol while diverting away from more costly services. Most of these clients are self-referred and brought in from multiple sources including local hospitals and the 911 system. Clients stay at this program just for the night.

The primary role of the EMT at both sites is to ensure clients are medically safe and respond within medical scope should the need arise. EMTs with Pioneer Human Services work closely with County MPDs and hospital staff for consults.

This position is unique to an in-field EMT in that it requires the provider to have or develop the ability to engage and monitor a person for an extended period of time. As an EMT, your responsibilities will include but not be limited to:

- Tracking baseline presentations and making sound judgements for the continuum of care.
- Managing clients in crisis at times and be part of a multi-disciplinary team to develop a successful plan.
- Respond to emergency medical situations within scope-of-practical should the need arise and make appropriate decisions per facility and county protocol.



In short, our EMTs possess the ability to provide medical oversight, collaborate with other providers on a solution while also engaging with clients on a long-term basis not experienced in the back of an ambulance.

The EMTs that work for us want more than short-term engagement with patients. They want to build their soft skills and have the ability to work with multiple providers. They are looking for that unique job experience that sets them apart from an EMT on a private ambulance or fire department. Using the valuable skills and knowledge our EMTs develop while working for us, countless have continued on to medical school, Physician's Assistant school, nursing and Fire Departments just to name a few.
